



Pimlico Gardens Park Public Consultation - FAQ

Welcome to the FAQ section for the Pimlico Gardens development public consultation, conducted by Westminster City Council. We understand that you may have some questions regarding the consultation process, the park's future plans, and related topics. Questions about the consultation

1. What is the purpose of the Pimlico Gardens development public consultation?

Additionally, Pimlico Gardens is an important location, particularly within the southern part of the borough, as it offers waterfront access, adding to its appeal and potential as a community recreational space. Following the success of previous initiatives such as the development of Paddington Recreation Ground as a community hub, the Council, Councillors, and the community has sought to develop Pimlico Gardens to serve as a south of the borough community hub. This designation presents an opportunity to develop Pimlico Gardens and connect with existing provision at St Georges Square Gardens, ultimately creating a community hub that currently lacks play and recreation facilities.

Our aim is to create a vibrant and inclusive environment where communities can come together, enjoy outdoor activities, and strengthen community bonds. Your input and support are vital as we work towards enhancing provision and improving the overall recreational experience in Pimlico Gardens.

11. Will there be any impact on the park's natural environment?

Preserving and enhancing the park's natural environment is a priority. The public consultation aims to strike a balance between development and the protection of the park's flora, fauna, and biodiversity. Your feedback will help guide these considerations.

12. Will the replacement project have any impact on the existing green spaces and natural elements in Pimlico Gardens?

16. Why is the Council exploring opportunities to expand or provide new forms of play in certain areas of Westminster?

The Council is exploring opportunities to expand or provide new forms of physical active play in specific areas of Westminster due to an overall lack of play facility provision and a shortage of facilities, particularly designed for older children and young people. Our Play Facilities Strategy (PFS) highlighted certain areas of the city, including Church

Street, Pimlico, Little Venice, East Marylebone, and Soho, have a shortage in play and informal recreational facilities, while also having a higher concentration of children.

To address this imbalance and ensure that children and young people in these areas have access to appropriate play facilities, the Council is keen to identify and develop open spaces to add play and informal recreational facilities. Through this initiative, we aim to create inclusive and engaging spaces where children and young people can participate in physical activity, promote healthy lifestyles, and foster community interaction.
